UK Foreign Secretary The Rt. Hon. David Miliband visit to Pakistan 16-17 Jan 09



The Foreign Secretary met the Pakistan President Asif Ali Zardari, Prime Minister Yousaf Raza Gilani and Foreign Minister Makhdoom Shah Mahmood Qureshi.

Discussions concentrated on Pakistan's relationship with India. They also discussed the wider issue of counter

terrorism, the improving relationship between Afghanistan and Pakistan and the global financial situation. This is the third time David Miliband has visited Pakistan in the last year which demonstrates the value placed on the relationship between the UK and Pakistan.

UK national security depends more than ever on a joint approach to tackling the forces of extremist violence on both sides of the Afghanistan and Pakistan border, the Defence Secretary The Rt. Hon. John Hutton MP said on his first visit to Islamabad.

"Both the UK and Pakistan face the threat of terrorism seeking to coerce our democratically elected governments into changing their policies by indiscriminate violence. Both our countries have suffered, just as India and other countries have suffered. The suffering will continue until the scourge of terrorism is dealt with at its root. That means embracing a strategy that deals with the threats on both sides of the Afghanistan and Pakistan border.

"You cannot kill, arrest, or legislate your way out of the terrorist and insurgent problems. Only a comprehensive approach that includes governance, social and economic development and respect for cultural differences can do that. The world faces global threats - most significantly, terrorism. These global threats require global solutions. Pakistan has a leading role to play in the struggle against extremism, and the UK will remain a constant and supporting friend and partner in the face of this challenge."

Pakistan and UK Ratify Transfer of Prisoner Agreement



Pakistan and the United Kingdom have exchanged the instruments of ratification of the agreement on the transfer of prisoners

between the two countries that will allow the prisoners from each others' countries to serve their sentences in the country of origin.

A certificate to this effect was signed on 19 August 2008 by the Pakistan High Commissioner to the UK HE Mr Wajid Shamsul Hasan and Director Consular Services, Foreign and Commonwealth Office, Julian Braithwaite, at the Old Admiralty Building, Whitehall.

The transfers require State consent as well as the blessing of the prisoners themselves. UK has PTA with over 100 countries worldwide. The Deputy High Commissioner Mr Manzur-ul-Haq said as of June 2008, there were 393 Pakistani nationals in prisons in England and Wales as against to 22 British nationals in Pakistani jails at the end of March 2008.

State Bank of Pakistan Introduces Commemorative Coin



The State Bank of Pakistan has introduced a coin bearing the portrait of the former Prime Minister Benazir Bhutto to mark the first Anniversary of her death in a suicide attack. The State Bank will issue 300,000 Dukhtar-e-Mashriq (Daughter of the East) Mohtarma Benazir Bhutto (Shaheed) Commemorative Coin of Rs 10/- denomination.

Metal Composition:

Cupro Nickel, Copper 75%, Nickel 25%.

Colour: White

Dimension: 27.5 mm

Weight: 8.25 gms

Obverse: The waxing crescent moon and a five pointed star facing north-west in rising position, is in the centre on the obverse side of the coin. Along with periphery on the top of the crescent star is inscribed in wording Islami Jamhoria (Islamic Republic) Pakistan in Urdu script. Below the crescent and at the top of two springs of wheat with arms curved upward, there is the year of issuance 2008. The face value of the coin in numeral '10' in bold letters and Rupee in Urdu Script are written on the right and left sides of crescent star respectively. A circle of small beads is all along the edge of the coin.

Reverse: In the centre of the reverse side, the coin bears portrait of Mohtarma Benazir Bhutto and inscribed in wording "Dukhtar-e-Mashriq Mohtarma Benazir Bhutto (Shaheed)" in Urdu script along with periphery on the top of the portrait. On the left and right sides of the portrait, year of birth and demise are inscribed respectively in numeral wording. A circle of small beads is all along the edge of the coin.

The existing Rs 10/- banknotes will continue to be legal tender and will remain in circulation along with the other Rs 10/- coins.

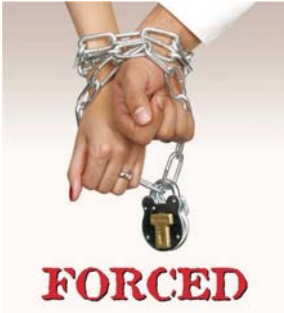
Commemorative Coins

The Forced Marriage Act



A new law gives the Criminal Justice System greater powers to stop forced marriages from taking place and to protect vulnerable victims.

If such a marriage has already taken place, the court can make orders to protect the victim and help remove them from the situation.

Under the Act, the family court can make a Forced Marriage Protection Order. For example, the court can make orders to:

- prevent a forced marriage from occurring;
- ensure passports are handed over;
- stop intimidation and violence;
- reveal the whereabouts of a person;
- stop someone from being taken abroad.

Police can arrest people suspected to be breaching a Forced Marriage Protection Order. Anyone in breach or contempt of an order could face up to two years' imprisonment.

FCO Forced Marriage Unit (FMU) is dedicated to preventing British nationals being forced into marriage overseas. If you are worried that you might be forced into a marriage or are worried about someone else who may you should contact them on:

020 7008 0151 (or 0044 20 7008 0151 if you are overseas)

FMU caseworkers deal with around 400 cases a year and are fully trained to deal with the emotional, cultural and social issues surrounding forced marriage. Anything you tell FCO FMU will be treated with complete confidentiality.

What is a forced marriage?

In a forced marriage you are coerced into marrying someone against your will. You may be physically threatened or emotionally blackmailed to do so. It is an abuse of human rights and cannot be justified on any religious or cultural basis.

It's not the same as an arranged marriage where you have a choice as to whether to accept the arrangement or not. The tradition of arranged marriages has operated successfully within many communities and countries for a very long time.

I'm frightened I might be forced into marriage during a family visit overseas, what should I do?

Call FMU on 020 7008 0151 before you go.

And you should think about whether you really want to go. Once you're there you may:

- be isolated
- face emotional pressure
- be watched all the time
- have no money
- not have your passport or ticket
- be a long way from a telephone

If you still decide to go you should make sure you leave the following with a trusted friend:

- full address and telephone number of where you are going to stay abroad
- your passport details
- all your flight details (there and back)

Find out where the nearest Embassy is and keep the phone number with you at all times. If you can, take some money with you.

My sister/ cousin /friend has not returned from a visit overseas and I'm worried she might have been forced into marriage, what should I do?

Contact 020 7008 0151. It will help FMU if you can give them as many details as you can such as:

- where the person has gone
- when they were due back
- when you last heard from them
- FMU will contact the relevant embassy on your behalf and they will then try to make contact with the person.

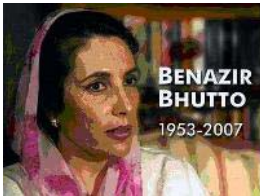
I was forced into a marriage overseas, can you refuse my spouse a visa to come here?

FMU may be able to but you must be willing to state publicly that you do not want your spouse to join you in the UK. Call 020 7008 0151 and FMU will advise you on what you can do. If you have been forced into marriage FMU Survivor's Handbook will offer you some advice and help you plan for the future.

2008 United Nations Prize in the Field of Human Rights



On 10 December 2008, the United Nations Human Rights Prize was awarded to individuals, including posthumously to the **former Prime Minister Benazir Bhutto** in

recognition of “outstanding achievements in the field of human rights”.

The prize was established in 1966 by the General Assembly and was first awarded on 10 December 1968, the twentieth anniversary of the adoption of the Universal Declaration of Human Rights. Past winners include **Begum Ra’ana Liaquat Ali Khan**, Nelson Mandela, Jimmy Carter, Martin Luther King Jr. and Eleanor Roosevelt, who played a key role in creating the Universal Declaration of Human Rights. Organizations that have won the prize include Amnesty International, the International Committee of the Red Cross, and the Mano River Women’s Peace Network in West Africa, while in 1998, the UN recognized the sacrifice and achievements of all human rights defenders across the globe.

In awarding the Prize, the UN is sending a clear message to those who stand for human rights and freedoms that the international community is grateful for and supports their tireless efforts to promote the Universal Declaration of Human Rights.

The Award is presented by the UN Secretary-General in the General Assembly every five years.

The Prize provides an opportunity for the United Nations to publicly commend the achievements and outstanding contribution of the awardees. Through this public recognition of the valuable work of the awardees, the United Nations also pays tribute to the thousands of anonymous human rights advocates and defenders involved daily in the difficult and often perilous work to promote and protect the rights of others.

The United Nations Prize in the Field of Human Rights was established in 1966 by a resolution of the General Assembly, 19 December 1966. The General Assembly envisaged the Prize as one of the ongoing measures by which the United Nations could honour and commend those who have made an outstanding contribution in the field of human rights, and to promote the human rights principles contained in the Universal Declaration of Human Rights (UDHR) and other human rights instruments.

The General Assembly first awarded the Prize on 10 December 1968, the International Year for Human Rights and the twentieth anniversary of the UDHR. It has since been awarded in 1973, 1978, 1988, 1993 and 1998. The Prize is always awarded on this date, as 10 December is the anniversary of the proclamation of the UDHR, and was declared Human Rights Day by a resolution of the General Assembly in 1950.

Obituary: Prof Ralph Russell

On 14 September 2008, Urdu language was deprived of the dedicated services of Prof Ralph Russell who as teacher and head of the Urdu Department at London University for close to 32 years passed on his passion, love and knowledge of the language to his students and friends and enriched the literature of the language with his scholarly research that earned him a unique and abiding place among great names of Urdu literature.



His death at the age of 90 will be widely mourned by his friends and admirers both in the UK and South Asian Subcontinent. The vacuum created by his passing will not be easy to fill. Russell accomplished some major works as the head of Urdu Department of the School of Oriental and African Studies, University of London. He wrote numerous research and critical essays in Urdu and made very popular and accomplished translation from the classical Urdu literature, which are read widely in the Western world. The Urdu translation of his memoirs titled Joinda-o-Yabinda was published only recently. He established such a system of Urdu teaching in Britain, which facilitated the learning of the language across Britain.

He has left behind many illustrious students in Europe and America. Government of Pakistan conferred the Sitara-i-Imtiaz upon him in acknowledgement of his valuable services for the promotion of Urdu.

ICC World Twenty20 England 2009



The ICC World Twenty20 England 2009 will be held in June 2009 and provides the opportunity to see the very best players in the world, representing their countries, showcasing Twenty20 cricket on a global stage.

The 2009 event sees both the men's and women's tournament integrated for the first time. The men's tournament format consists of 12 teams, played across three venues – Lord's, Trent Bridge and the Oval. A key feature of the 2009 event is that the majority of match-days will include two games showcasing four different teams. This double-header format allows spectators to view two games for the price of one match-day ticket.

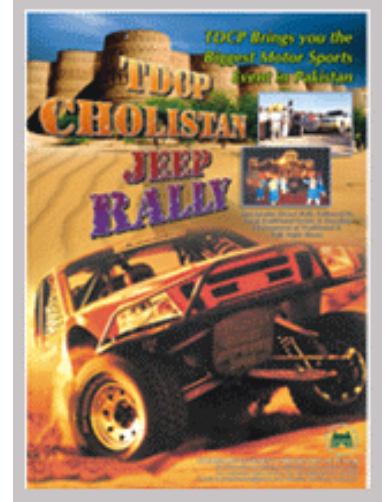

Miss Pakistan runner up set to take off at Miss Earth 2009



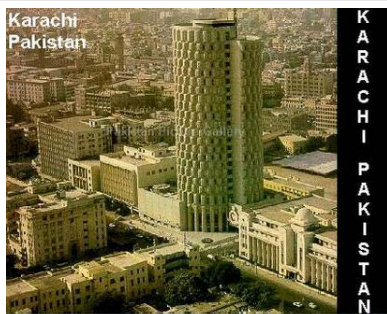
